**General Comments** 

The Quality Assurance Monitor is on site for a follow-up inspection. Ratio was respected during the visit.

While on site the Quality Assurance Monitor had a discussion with the administrator in regards of how the educators divided the children to ensure that no groups exceed the need of 2 educators and to ensure that children always get proper supervision. The administrator explained to the Quality Assurance Monitor that when the first group of children arrive at the centre they are divided in 2 separate groups , one being in the small square part of the facility and the other one being in the bigger part of the facility. Once the second group gets to the facility, the group from the smaller square part of the facility goes outside and the remaining children in facilities are allowed to circulate throughout all sections of the room. The administrator has confirmed that one educator is to remain in each section of the room to ensure the proper supervision of children. The Quality
