<p>General Comments</p> <p>Upon Licensing staff arrival, the children were finishing lunch. Today, was hot lunch day with pizza. Many of the children had pizza and some were having their lunch from home. Those who finished eating early, were observed playing in the main playroom with boardgames, magnet tiles, puzzles and blocks.</p> <p>The play spaces in each of the playrooms were neat and tidy. The material was clean and in good condition. Each room had centres set up with materials such as a large doll house, play kitchen, labelled bins of K'nex, Lincoln Logs, blocks, dominos, trains, and marble tracks. The library room had a large selection of books, carpets, wooden chairs, a table and a multi-coloured lamp. In one of the rooms there were butterflies cut out on the wall with each child's name and phrases written on how to play nice and be kind.</p> <p>After lunch the children played freely indoors. The transition between play time and getting ready for the next activity was smooth as a time warning was given for clean up. An Educator was observed reading a story to the children and then explaining the upcoming October activities, while another Education sat with a child helping solve a small disagreement with a friend.</p> <p>Later in the afternoon, the children made a skeleton craft. Educators assisted the children by painting their hands with white or silver glitter paint to make a handprint on construction paper. A few of the children helped by passing out Q-Tips to create the bones for the skeleton. Positive words of encouragement and affirmation were heard such as "good job!" and "that looks great!".</p> <p>Snack time was also observed. The children were again given a 5-minute clean-up announcement and then</p>

took turns washing their hands. Some of the children chose snacks from their lunch bags and ate together at the table while some children chose not to have a snack and continued to play in the main playroom. After snack, the children packed up their backpacks to end the day after in the nature park for end of day pick up.

The main entry was welcoming, and the children's belongings were organized on hooks with their names. The parent board was visible with required postings and a monthly calendar with planned activities. Child and staff files were organized and contained all required documentation.
