During the follow up to the renewal inspection conducted on September 15, 2021, additional non-compliances were observed.

Discussed with operator, administrator and educators: Maximum group size of 30 school age children. During the inspection the room was not divided and the children in attendance exceeded maximum group size. Administrator and educators were instructed to divide the group to ensure maximum group size was not exceeded. There is a curtain that can be used to divide the room or shelving arranged in such a way as children stay in their own groupings with their educators and not go into the other group. Moving forward, once the number of children exceed 30 school-age children in the room, the room must be divided to support both groups.

Discussed that all new educators must have a copy of a new SD Record check in their file and they cannot work at the childcare facility until one is received, First Aid/CPR training; educators cannot be alone with the children at any time unless they have completed this training.

Discussed the use of masks. During inspection it was observed the educators going between the groups. When this occurs, educators must wear their masks. School-age children in daycares will need to wear masks at all times as staff work to reduce contact between groups of children as much as possible. Staff who are fully vaccinated will continue to wear masks in common areas and may remove their masks within their own group of children. Unvaccinated staff must wear masks at all times.
