Children and educators observed engaged in a variety of activities this morning including sensory opportunities, open-ended art, and dramatic play. The environment is set-up with a variety of materials and invitations that support the children's current interests (dinosaurs, spicy food and rainbows).

Documentation is displayed throughout the environment that supports the interests and learning experiences of the children. The children have been talking about spicy food and hot sauce. Educators have documented the children's conversations and questions on this topic. Each child had the opportunity taste test black pepper if they chose and added their name to the list if they liked spicy food or not.
