Renewal inspection was completed today along with the relocation inspection as operator has recently moved into a new home. The environment was set up in an inviting way with interest areas throughout the rooms. The operator engages the children with ease and sets up purposefully planned invitations to spark the children's interests.

During the time of inspection, the children engaged in dizzy play as they sang songs together, danced to some of their favorite songs and took imaginary trips to the moon.

The children also eagerly explored an open ended invitation that incorporated cotton balls, clothespins, paper and water. The children were encouraged to playfully explore these materials while the operator asked open ended questions to promote and extend the children's ideas.

The children's learning has been documented through photographs and creative art. Photos are uploaded for

parents to review and the children are able to revisit these memories as the photos are sometimes displayed on the TV as a slideshow.

Outdoor play was not observed during today's inspection, however, photos of the children within their outdoor environment were noted and the children recalled past memories of their time outdoors.

Essential visitors to the ELC home are being actively screened prior to entering. Required documents (i.e. group logs, acknowledgement of screening responsibility, and visitor log, etc.)relating to COVID-19 were reviewed and are being completed as required.
