The child's record file must include name, address and telephone number of at least 2 emergency contact. The operator must make sure that all child records are complete. Comments: While verifying new staff members file, the Quality Assurance Monitor observes that one educator does not have a valid first aid certificate and a valid cardiopulmonary resuscitation certificate that is approved in the worksafe NB first aid providers. All educators must have a valid first aid and cardiopulmonary certificate. The staff member can not be left alone with the children until an obtention of a valid CPR certificate. The operator informs the Quality Assurance Monitor she will register the staff member to complete her certification in the next coming weeks.

Comments:	omments: In one classroom, 8 children were present but only 7 were signed in on the attendance sheet. Using the attendance form provided by the department, the attendance records must be completed each time a child arrives and leaves and must be accurate and reflect all children present at any given time. Educators immediately signed in the child.Deficiency is now compliant.								

## **General Comments**

The Quality Assurance Monitor is on site to conduct the renewal inspection. The ratio was respected during the inspection.

At the time the Quality Assurance Monitor arrived, the children were gone for a walk to play at the parc, the temperature was very warm. The Quality Assurance Monitor observed the children's bottles of water left on the tables at the facility. The Quality Assurance Monitor asked the operator what her plan was if the children were thirsty. The operator informs the QAM that she would bring the bottles with the bus to the parc.

The QAM observed challenges during a group's transition from the classroom to the washroom. The group was divided in two in order to smooth the washroom transition. The children were lined up against a shelf, and the wait time was approximately 5 minutes. The children were getting reckless, and the educator was reminding them to stand up and to get back in line. The QAM provided recommendations to the educator to help reduce transition time and promote smoother routines. The QAM had a discussion with the administrator regarding routines, the administrator informs the QAM that she is working together with the educators to find solution.

The QAM observed the children returning to the center from their walk and playing and the parc. The children were observed transitioning to lunch time and then nap time. The children woke up at 2h00. The children were observed eating their snack while the school-aged children arrived at the center. The temperature was too warm to go outside in the afternoon, the children usually go play outside after their afternoon snack and activities.

One classroom had a floor book activity while another classroom tasted honey on a popsicle stick that was part of their learning story that they have been doing the past couple of days. The children expressed interest in bees after seeing bees outside.
