<p>General Comments</p> <p>Licensing staff arrived at the licensed early learning and child care home for the annual renewal inspection. Upon arrival, one child was leaving for an appointment, and the other child was engaged in free play and listening to music. The child was observed looking at coloured beads and naming the colours with the operator. The child then had snack. Snack was strawberries, yogurt, and toast. The child and the operator were seen looking at wooden letters together before getting ready to go outside. The other child returned and joined them outside. While outside, the children were seen playing on the swings, with the music board, and driving miniature cars on different surfaces.</p> <p>Once they returned inside, the children played with wooden letters and hopped on Farm Hoppers while the operator was preparing lunch. The children ate their pizza and the operator sat and ate with them. The children got cleaned up and chose books. They then sat with the operator to read them together. The operator was heard asking questions to the children. The operator changed pull-ups/diapers before it was time to get settled. One child got settled on their nap cot and the other did quiet time.</p> <p>The operator speaks kindly to the children and engages in conversation with them. The operator kneels when speaking to the children. The indoor environment was clean, and various resources were accessible to the children on low, open, and labeled shelves.</p> <p>Required documentation and files were checked and found to be complete. Only positive child guidance was observed.</p>
