General Comments
<p>Visit to the facility for the annual inspection. Ratio was respected during the visit.</p> <p>A staff member did not have their file on site, this was retrieved immediately. Reminder that replacement staff must have their file on site. The administrators file on site is not up to date. An up to date file must be kept on site at all times.</p> <p>There is a presently a play house in the outdoor area with sharp objects in it (nails sticking out, broken cabinet with sharp edges etc). The facility d has put safety measures in place and do not permit the children to use this part of the play area at this time. Recommending that this area be cleaned up so this play space can be used again.</p> <p>A staff member had a hot coffee in a mug around the children. This was addressed and the staff member was asked to put their coffee away.</p> <p>Observations: Children participated in floor and table activities. The afterschool children arrived and they had snack.</p>
