General Comments

Licensing Staff arrived at Facility to perform a Monitoring Inspection. Upon arrival children were having free play. Some children were coloring, building with K'nex and playing Super Mario Monopoly. A group of children had set up a Cat Spa. They had brushes, stuffed animal cats, a cash register and money they had made. Educator gave the children a 5-minute warning before cleaning up. Once the children had cleaned up, they gathered on a carpet, waiting to be picked to wash their hands for morning snack. Educator sat with the children as they ate, engaging in conversation and giving reminders to stay at the table while they were eating.

As the children were finishing snack, an Educator encouraged them to use the washroom before getting their sunscreen on. The Educator gave multiple reminders for sunscreen and water bottles, periodically checking in with the children to see how they were making out. The tables and benches were cleaned after snack, and the floors were swept. Once all the children had sunscreen on, they lined up at the door for a headcount. The Educator did Roll Count and a final headcount as they left the building to go to the park. A bookbag with a First Aid Kit and Attendance records was brought. As the group approached the Crosswalk in front of the playground, an Educator did a headcount and reminded the children to gather by the swings until a Safety Check of the Playground was complete. Once the Safety Check was complete the children were able to use the swings, slides and the soccer field. A soccer ball, board game and coloring materials were also brought to the park.

Attendance Records are being tracked daily and Incident Reports are being used. As a reminder, please ensure the Stick Bug Aquarium is being cleaned regularly.
