General Comments

Licensing staff arrived at the facility to perform a Monitoring Inspection. Upon arrival, one Educator was in the classroom with a small group of children. Shortly after, the bus arrived with the second Educator and another group of children. Once the children hung their coats and bookbags up, they gathered at the tables for lunch. Once a few children had finished eating, a table was cleaned, and an activity was set up.

The transition from lunch to activities was smooth. The children had the option of finding a station to play at or have electronic time. Children were observed playing with Perler Beads, sewing, coloring and playing with barbies. One Educator set out small bowls with baking soda and a large bowl of vinegar. Food coloring and pipettes were set out for the children to use. An Educator was heard giving the group a verbal reminder to clean up. Children worked together to put away materials before gathering at the reading area for a quick game before washing hands for afternoon snack. As the children finished eating, they backed their bookbags and got dressed to go play outside.

The reading area and building station need to be re-organized and de-cluttered. Several books are ripped and should be replaced or removed. Bins containing wooden train tracks and cars were overflowing. Please remove any broken toys and ensure there are enough bins for the materials to fit in properly. Staff files and child profiles were reviewed during today's visit. Please ensure that all required documents can be found on site. Attendance records and potential illness forms are being recorded. Educators were attentive to the children; only positive child guidance was observed during Monitoring Inspection.
