### General Comments

The Quality Assurance Monitor is on site for a monitoring inspection.  
Ratio is respected during the visit.

While on site the Quality Assurance Monitor verified  
-Posted in a visible and prominent place in the facility  
-Indoor play area materials and equipment  
-Personal belongings

During the monitoring inspection, the Quality Assurance Monitor observed children playing outdoors.

A discussion was had between the Quality Assurance Monitor and the operator in regards of how chaotic the transition of children arriving from school was. The Quality Assurance Monitor mentioned to the operator that when they arrived on site, the Quality Assurance Monitor asked the educator how many children were present today. The educator mentioned having 13 children, while the educator was signing children in on the attendance sheet. The Quality Assurance Monitor proceeded with asking the educator if children had been physically seen before signing them in on the attendance sheet. The educator mentioned having seen the children while they were coming out of the door at the school. The Quality Assurance Monitor questioned if the educator were able to point out where the 13 children are on the play structure, as there are a lot of children that are not related to the daycare on the park. The educator confirmed not being able to point out the 13 children. The Quality Assurance Monitor questioned the educator how they ensure that children don't leave with another child and their parents from the park if they are not able to locate all 13 children. The educator replied that there are 3 educators, one at each end of the park. The Quality Assurance Monitor requested that the educator call out the children to confirm the number of children. The educator was able to gather all children within a few minutes and the Quality Assurance Monitor was able to confirm the number of children.

The Quality Assurance Monitor recommended to the operator that if children remain outside directly after school where children who are not a part of daycare will be mixed in with daycare children on the playground that they use their daycare-colored shirt to ensure they are able to always locate their children. Both the administrator and operator agreed that in the future the children will wear their daycare-colored shirt if they play directly outside after school.

## General Comments

Another discussion was had regarding staff members being unaware of who their partners are. The Quality Assurance Monitor mentioned that when the second group of children arrived the educator mentioned to the Quality Assurance Monitor having 19 children and stated that no other educator was with them. The operator informed the Quality Assurance Monitor that a staff member to whom is a support worker, when the last group of children arrive and by the time operator confirmed being in ratio with the other educator in reason of staff members being absent. The Quality Assurance Monitor reminded the operator of the importance of staff members knowing what role they always play.
