Today is the first day for the new educator. She was engaged with the children and assisting them when needed.

When I arrived, the children were playing with sensory bins and some were doing arts and crafts.

No emergency plans posted. Please ensure they are posted at both doors.

General Comments

Staff files are not complete. Please ensure the new staff read the Act and Regulations and sign a declaration attesting that they did. A detailed job description must also be added to their files.

Please make note of the COVID-19 Guidance for Early Learning and Childcare Facilities document. This can be found on the Operator or Parent Portal.

Base on my observation, cleaning and disinfecting guidelines for COVID-19 are not being followed. Accessories in sensory bins must be cleaned daily and sand discarded every two weeks. The area rugs had debris and lint all over them which tells me they are not vacuumed daily. Children were sharing bins of beads and playing with tread; therefore, those need to be quarantined for 72 hours. Arts and crafts materials that can be disinfected like scissor must be done daily. Dog beds used for sitting have not been washed therefore should not be used if not washed daily. Blankets also should be washed daily.

COVID-19 cleaning guidelines must be reviewed with staff to ensure they are following guidelines.
