Toxic products are now kept in a locked cabinet upstairs.

A reminder that children should wear indoor footwear at all times.

A new arrival routine has been established with the after schoolers. Educator now keeps the children outside to play until all buses arrive. This appears to be working great as the children are happy to play outside after being in school all day.

Educator and administrator were observed removing broken toys from the children's outside play space at time of visit.

The educator was observed giving children gentle reminders to put their masks back on when they were finished eating. Educator was also observed being attentive to the children at time of visit, and ensuring that they all had their hats and mittens on while outside so they wouldn't get cold.

Children's hooks have been moved closer to the door making it easier for them to hang up their belongings when they come inside.

Children were very excited when they heard that they were having rice crispy squares as a special snack today. Snack was prepared and already upstairs before the children arrived.

Please note that it is the operator's responsibility to ensure that the outdoor play area (example - the climbing dome) is surrounded by a protective surfacing of the appropriated depth come spring time once the snow melts. Please refer to section 9.3.2 of the Operator's Manual to maintain compliance.
