<p>General Comments</p> <p>Licensing staff arrived at the facility at 1:45pm. Upon arriving the pre-school aged children were engaged in free play activities such as playing with Legos, dolls, trains and train tracks and others were coloring. The educators were observed engaged in the children's activities. One educator was observed sitting and coloring with a group while another educator was observed sitting in the dramatic play area and playing with dolls and other accessories.</p> <p>At 2:10pm, the after-school children were observed storing their personal belongings in their cubbies before entering the classroom. The educator was observed greeting the children at the door and asking them how their days went. The children were observed engaging in free play activities such as playing chess, making paper airplanes, coloring and playing in the dramatic play area. The educator was observed engaging in the children's interests.</p> <p>Before transitioning, an educator was heard giving a verbal prompt to the preschool aged children and put a visual timer on. Once the timer went off, the educators put on a cleanup song and were observed cleaning up with the children. After, the educators were observed sanitizing the tables and encouraging the children to use the washroom before the afternoon snack. The educators were sitting at the tables with the children as they ate. After eating, the educators prompted the children to get ready to go play in the gym.</p> <p>The indoor environment was clean and well organized. Both classrooms had a variety of indoor play materials located on accessible shelves. The children's personal belongings were properly stored and labeled. Learning stories were posted on the walls with pictures of the children while at play. A planning web with a question was posted on the white board.</p>
