## **General Comments**

During my visit I observed the COVID guidelines being followed, including screening me upon entry, temperature taking and recording, splitting the children into separate groups (bubbles), having enough supplies for disinfecting, and proper hand washing.

There are still a variety of materials and activities for the children, even after putting some materials away to ensure proper cleaning. The materials are swapped out with others while they are being cleaned. The program appears to be active, and the children appeared to enjoy playing with each other and the materials, looking at family photos, listening to music, and drawing pictures after going outside.

I observed positive child guidance, such as encouragement, gentle reminders, and they showed care and compassion to the children. I observed the educators being actively engaged with the children, and they were responsive to the needs of the children.
