While the Quality Assurance Monitor was on site, the educator told the Quality Assurance Monitor that an email was sent out to the parents to explain that all children personal belonging including the lunch box must be labelled with the child's name, the educator said that a lot of parents responded and added the child's name on the lunch box but they still had some that did not add the child's name. The educator told the Quality Assurance Monitor that a second email would be sent out as a reminder and after that if the lunch box is still not labelled the educator will write it herself in the child's lunch box.
