Comments: In 7 child records verified the child's name, address, birth date and Medicare number was filled out. Deficiency is now compliant.

Comments: In 1 out of 7 child records verified the name, address and telephone number of the medical practitioner was missing. The quality Assurance Monitor gave a second reminder to the educator that all child records must contain the name, address, and telephone number of the medical practitioner. The educator showed the Quality Assurance Monitor the list and the outgoing emails to the parents of the children who are missing information in their child records. The educator also mentioned that a second email will be sent out to parents to remind them that this information is urgently needed.

Comments: The Quality Assurance Monitor observed that all children water bottles were labelled with the child's name. Deficiency is now compliant.

48(2) An operator of a licensed facility may supply food to a child receiving services at the licensed facility that a parent or guardian of the child brings from the child's home if the food is labelled with the child's name and refrigerated, as required.	48(2)	Nov 10, 2023	
Comments: 3 lunch boxes were not labelled with the child's name. All food brought from home must be labelled with the child's name.			

<p><b>General Comments</b></p> <p>The quality Monitor is on site for a follow-up inspection. The ratio was respected during the visit.</p> <p>While the Quality Assurance Monitor was on site, the educator told the Quality Assurance Monitor that an email was sent out to the parents to explain that all children personal belonging including the lunch box must be labelled with the child's name , the educator said that a lot of parents responded and added the child's name on the lunch box but they still had some that did not add the child's name. The educator told the Quality Assurance Monitor that a second email would be sent out as a reminder and after that if the lunch box is still not labelled the educator will write it herself in the child's lunch box.</p>
