The educator in charge immediately printed a copy of the board members and posted it right away. Deficiency is now compliant.

Comments:	During the follow-up inspection, the Quality Assurance Monitor asked the educator how many children were present. The educator voiced to the Quality Assurance Monitor that she had 16 children and the other educator had 15. The Quality Assurance Monitor notice that there was also a dance instructor in the room, and proceeded to ask the educator if the dance instructor was in ratio with the group of 16. The educator informed the Quality Assurance Monitor that all 3 educators share the responsibility of all 31 children. The Quality Assurance Monitor explained to the educator in charge of the situation and explained that a group cannot exceed the need of 2 educators. The educator in charge and the Quality Assurance Monitor had a discussion and the educator in charge will have a discussion with the educators to ensure they understand how to divide the group and to ensure that a group never exceeds the need of 2 educators. Deficiency is now compliant.
