Comments: Walls are showing wear and paint chipping throughout, requires fresh coat of paint.

Comments: Art materials are becoming depleted (insufficient amount of markers, glue and paper).

Comments: Within the dramatic play area, the rug is unclean and needs to be replaced. The play kitchen also requires cleaning. Within the reading area, the pillows are unclean and need to be removed. The bookshelf is collecting dust and debris and many books are not in good condition. Books should be replaced. Light green and blue shelves both have paint chipping away and require fresh coat of paint. The blue shelf that is used for mat storage also has an exposed nail that needs to be fixed. Some mats are in poor repair (rips and tears), need to be removed.			

General Comments
<p>Completed monitoring inspection today. The children participated in a fashion show with dress up clothes brought from home and materials within their environment.</p> <p>There was lots of open ended art displayed throughout the room.</p> <p>Recommending to change up the dramatic play area based on the children's interests (ex: store, salon, teacher's desk/office space, medical center, etc.). Discussed the recommendation of adding hooks to the wall for hanging up dress up clothes.</p> <p>Also recommending to organize/utilize the cabinet space with individually labelled open bins to make the art area more inviting. Moving the table closer to the art cabinet would also make these materials more accessible.</p>
