Children observed engaged in a variety of activities this morning including gym games, volleyball, basketball, fort building, and open-ended art. A Maker Space has been added to the environment, where children can build with a variety of loose parts and hot glue.

This room is in need of some decluttering, excess materials to be removed and stored in a place where educators can rotate them into the environment as interests emerge. Discussed with staff using smaller bins and organizing materials by type.

Monthly fire drills are documented.

Daily attendance forms are completed.
