Comments: During the follow-up inspection, the inspector observed that daily activities are not deliberately planned in two out of the 5 classrooms. As mentioned on December 15, the operator must ensure that programming is deliberately planned and documented.			
22 The daily routine of a licensed facility shall include (a) outdoor play for at least one hour in each four-hour block of time when the majority of children receiving services are in attendance except in the following circumstances: (i) the wind chill is below -20 °C; (ii) the temperature is below -20 °C; or (iii) the temperature is 33 °C with humidity or above.	22(a)	Dec 15, 2023	Jan 10, 2024
Comments: During the follow-up inspection, the inspector observed that all children engaged in outdoor play. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed that the daily information sheets are complete for all children under 24 months. Deficiency is now compliant

Comments: During the follow-up inspection, the inspector observed that the daily routine is posted in all classrooms. Deficiency is now compliant			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (d) permitting the administration of emergency care to the child.	27(d)	Dec 19, 2023	Jan 10, 2024
Comments: During the follow-up inspection, the inspector observed that the consent for administering emergency care is present in the 6 child files verified. Deficiency is now compliant.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (f) permitting the child to participate in an outing.	27(f)	Dec 19, 2023	Jan 10, 2024
Comments: During the follow-up inspection, the administrator informed the inspector that consent for outings had been destroyed following the outings and that going forward the consents will be placed in the children's files. Deficiency is now compliant.			
28(3) The premises of a licensed facility shall comply with (a) lighting, ventilation and other general health standards under the Public Health Act.	28(3)(a)	Dec 15, 2023	Jan 10, 2024
Comments: During the follow-up inspection, the inspector observed that mouthed toys are removed from play in order to be disinfected. Deficiency is now compliant.			
30(3) An operator shall maintain the indoor play area of a licensed facility to ensure the safety of the children.	30(3)	Dec 22, 2023	
Comments: During the follow-up inspection, the inspector observed that the ripped couch has been covered with a fitted sheet. As mentioned on December 15, the operator must repair the couch to ensure that it can easily be cleaned or dispose of the couch.

Comments: During the inspection, the inspector observed that art materials are accessible in the toddler room. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed that mouthed toys are removed from play in order to be disinfected. Deficiency is now compliant.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Dec 15, 2023	Jan 10, 2024
Comments: During the follow-up inspection, the inspector observed a bottle of window cleaner on a counter in one of the classrooms. During the inspection, an educator placed the bottle in a locked storage cabinet. Deficiency is now compliant.			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (a) labelled with the name of the child.	40(1)(a)	Dec 19, 2023	Jan 10, 2024
Comments: During the follow-up inspection, the inspector observed that the 8 water bottles verified are labelled with the child's name. Deficiency is now compliant.			
46(3) If consent is oral under subsection (2), the operator of a licensed facility shall require the parent or guardian to give a written acknowledgement when the child is picked up at the licensed facility that acetaminophen was administered with their consent.	46(3)	Dec 15, 2023	Jan 10, 2024
Comments: During the follow-up inspection, the inspector observed that written confirmation from the parents is provided when the facility administers acetaminophen. Deficiency is now compliant.			
46(4) An operator of a licensed facility shall maintain a chronologically filed medication record of all medication administered to a child.	46(4)	Dec 15, 2023	Jan 10, 2024

Comments: During the follow-up inspection, the inspector observed that records are kept when medication is administered to the children. Deficiency is now compliant.			
50(2) The operator of a licensed facility shall inform the parent or guardian of a child involved in an incident on the day the incident takes place and shall ensure that the parent or guardian signs the daily log to confirm their awareness.	50(2)	Dec 15, 2023	
Comments: During the follow-up inspection, the inspector observed that one out of two incident logs audited had not been signed by the child's parent / guardian. . The Operator must ensure that all minor incidents are properly recorded, documented and signed by parents/guardians so that parents/guardians are well informed of any incidents that may have involved their child while at the facility.
