Comments: The play structure inside the daycare is made of wood and the bars are less than an inch apart. The slide is commercial, no protective surface. The structure is currently closed with an shelf. During my visit, no child was around the indoor play structure. The structure is not stable, it wobbles and it should be hung on the wall. Discussion with the operator of the possibility of removing the play structure from the daycare.			
31(3) An operator shall maintain the outdoor play area of a licensed facility to ensure the safety of the children.	31(3)	Jun 18, 2021	
Comments: Protective surface (not yet 30 cm) has been added under one of the structures. It's important to remove large rocks from the protective surface and the protective surface should be 1.8m away from the play structure. The operator has been advised that she should not let them play in structures that are not compliant. The protective surface for the play equipment is not sufficient (less than 1-3 inches depending on the structure). Outdoor play structures cannot be used if they do not have the protective surface required by the manufacturer's manual or CSA. It's important to scrape for the protective surface to conform. In addition, you need to remove medium and large rocks from the protective surface.			
33(2) Stationary equipment in the outdoor play area shall be surrounded by a protective surfacing and installed according to the manufacturer's instructions.	33(2)	Jun 25, 2021	
Comments: Materials have been ordered to repair the commercial structure in the outdoor park which should not be used until it has been repaired. Protective surface (not yet 30 cm) has been added under one of the structures. It's important to remove large rocks from the protective surface and the protective surface should be 1.8m away from the play structure. The operator has been advised that she should not let them play in structures that are not compliant.

Comments: The first aid kit isn't complete and expired products must be replaced.			

General Comments

The daycare meets the requirements of the Early Childhood Services Act and New Brunswick regulation according to the ratio and personal belongings.

Before this afternoon's activity, it's important to have the consents of all parents as well as the consent for transportation.

I observed the snack (either brought by parents or provided by the daycare). The children are outside at the end of my visit. The fence gate is closed when the kids are playing outside.
