30(3) An operator shall maintain the indoor play area of a licensed facility to ensure the safety of the children. Comments: A storage door handle in one classroom next to the play area has a door knob that is not installed properly. The key lock part is on the door handle is on the inside of the storage and the locking mechanism is on the outside. To avoid accidentally locking someone in the storage, the door knob must be installed in the proper position.	30(3)	Sep 17, 2021	
33(2) Stationary equipment in the outdoor play area shall be surrounded by a protective surfacing and installed according to the manufacturer's instructions. Comments: Some of the structures in the playground does not have the required 30 cm depth of protective surface. The Administrator must ensure that the correct amount of protective surface is in place before the children are allowed to use the play structures. Administrator indicated that the structures will not be used until the required surfacing is in place. Deficiency is now compliant.	33(2)	Sep 15, 2021	Sep 15, 2021
37 An operator of a licensed facility shall not permit a child receiving services at the licensed facility access to the kitchen unless the child is supervised. Comments: The kitchen door was not locked at the time of the inspection. The door was locked when brought to the attention of the Administrator.
