Comments: During the follow-up inspection, the inspector observed that consent for transporting the child or providing transportation is present in 4 of the 4 files audited. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed that 10 out of 10 water bottles are labelled with the name of the child. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed that 8 out of 10 lunchboxes are labelled with the name of the child. During the inspection, an educator added the missing names to the lunchboxes. Deficiency is now compliant.
