All Educators were observed using words of encouragement and were attentive to the needs of the children. Educators were heard speaking kindly and with respect when interacting with the children Deficiency is now compliant			

General Comments
<p>Licensing Staff arrived at the facility to conduct a follow up Monitoring Inspection. Upon arrival, the Senior Infant class was outside playing in the smaller fenced in playground. The children in the 2-year-old classroom were playing outside in the larger fenced in playground. The other classes were inside the facility engaged in a variety of activities.</p> <p>Outside, the classes were observed singing songs, sliding down the slide and looking at birds and squirrels. The Educators were attentive to the needs of the children, wiping noses and ensuring hats and mittens were on. The transition back inside the facility to prepare for lunch time was smooth. The Educators held the hands of the infants as they walked across the parking lot and took them one at a time down the stairs into the facility. After all outdoor gear was removed and indoors were on, the infants sat at a table looking at books while one Educator heated up lunches. The Educators were engaged during mealtime and offered assistance when needed.</p> <p>Inside, the children in the 3-year-old room and 4-year-old room were observed having free play before getting ready for outside. The Educators encouraged independence as the children prepared for outside and as they returned back inside the facility. All classrooms were observed going outside this morning. Educators were heard singing or telling stories which made for smooth transitions. Only positive child guidance was observed during today's visit.</p>
