### General Comments

Licensing Staff arrived at the facility to conduct the Renewal Inspection. Upon arrival, children were continuing to arrive at the facility for morning drop time. Families were greeted by staff, and attendance records were promptly updated. The classes remained indoors during this time and, shortly after arrival, began preparing for morning snack. In the Junior Infant Room, one Educator was observed seated in a chair while holding an infant who was being fed a bottle.

The indoor environment was observed to be welcoming, bright, and engaging. Hallways, classroom doors, and classroom spaces displayed children's artwork, photographs, learning stories, and demonstrated the connect to curriculum. As the classes finished morning snack, the preschool groups transitioned to the fenced outdoor play area, while the infants prepared to go for a walk. Water bottles, attendance records, and first aid kits were brought outside with each group.

The outdoor play area provided a variety of age-appropriate play materials and opportunities for exploration. A wooden storage shed containing additional supplies was also observed. A small group of children were observed playing together in a large sandbox. The children collected various wildflowers and brought them to the sandbox, where they created their own garden. Other children participated in a variety of activities, including blowing bubbles, completing an obstacle course, swinging on the swings, and playing in the wooden playhouse.

The transition back indoors was smooth. Diaper-changing procedures were followed, and handwashing was observed. Children who do not nap remained engaged in activities across two classrooms. Children were observed coloring, playing with dolls and related accessories such as blankets, clothing, and cribs, while others engaged in imaginative play in the play kitchen.

The children appeared familiar and comfortable with both the environment and the daily routine. Staff and child files were reviewed and verified to be in compliance. Only positive child guidance practices were observed throughout the inspection. Educators were observed singing songs with the children, engaging in their play, and providing encouragement and praise as children demonstrated sharing and kindness toward one another.
