| Comments: As set out in the Early Childhood Services Act and Licensing Regulations, it is the Operator's duty to ensure each staff member has obtained a check with Social Development prior to employment, demonstrating no contraventions against the Family Services Act. During the inspection on August 5, 2020 it was found that an educator had a check with Social Development (SD Check) but was not dated. Educator may not return to work at the facility until new dated SD check is provided to the Inspector with no contraventions. | | | |

It was observed during today's inspection that the last monitoring visit inspection reported dated January 23, 2020, was not posted. It was also observed that last year renewal inspection report dated June 27, 2019, was not posted. | | | |

Observed educators effectively supervising the children to ensure proper hand washing.

A reminder that when children are resting on mats, but remain awake, that they are not required to stay on the mat for longer than 20/30 minutes.
