Comments: March 2022 evacuation was not conducted. May 2022 was conducted but not documented on the side of the license with the older children. Administrator acknowledged that these were missed and they have conducted evacuations monthly since missing in March.

General Comments I attended the daycare for renewal inspection. Ample and varied toys, books, games, and art supplies were observed in indoor play areas. The outdoor play space had varied activities and all supplies were in good repair.

General Comments

I observed positive child guidance during my inspection including redirection and comforting the children when they were upset. Music was played for the children during nap time. Evidence of learning was documented in write-ups by educators on the walls as well as art projects completed by the children on the walls.

I observed many missing immunization records but otherwise children's files were well-maintained - see above for the direction regarding the immunization records.
