<p>General Comments</p> <p>The Centre appeared clean and organized.</p> <p>One educator was observed dancing and singing with her group of children.</p> <p>Outside the children painted and played with the water tables.</p> <p>Outside the educators were engaged with the children. One staff was observed walking around the classroom with her hands in her pocket, not engaging with the children or sitting at the child's level when speaking with them. Staff engagement will continue to be monitored.</p> <p>Ongoing lack of positive reinforcement and encouragement when the educators are communicating with the children. Child guidance will continue to be monitored.</p> <p>The Implementation of the New Brunswick Curriculum Framework will also continue to be monitored.</p>
