Comments: In 1 of the 6 child record files verified the address of the emergency contacts are incomplete. The city part of the addresses is missing. The child's record file must include name, address and telephone number of at least 2 emergency contact. The operator must make sure that all child records are complete			
36(3) The rest area of a full-time early learning and childcare centre and an early learning and childcare home shall be equipped with the following: (a) a crib or portable playpen for each child under 15 months of age in accordance with the Cribs, Cradles and Bassinets Regulations and the Playpens Regulations under the Canada Consumer Product Safety Act (Canada).	36(3)(a)	Apr 14, 2025	
Comments: While doing the renewal inspection, the Quality Assurance Monitor observed a child under 15 months sleeping on a cot bed on the ground. Each child under 15 months must have a designated crib or playpen that meets the Cribs, Cradles and Bassinets Regulations and the Playpens Regulations under the Canada Consumer Product Safety Act.			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (a) labelled with the name of the child.	40(1)(a)	Apr 17, 2025	
Comments: The Quality Assurance Monitor observed that the water bottles were not labelled with the name of the child. Personal belongings must be labelled with the name of the child.			
48(2) An operator of a licensed facility may supply food to a child receiving services at the licensed facility that a parent or guardian of the child brings from the child's home if the food is labelled with the child's name and refrigerated, as required.	48(2)	Apr 17, 2025	
Comments: The Quality Assurance Monitor observed 3 lunch box or lunch container not labelled with the name of the child's name. Food brought from home is labelled with the child's name.			

General Comments

The Quality Assurance Monitor is on site for the renewal inspection. The ratio was respected during the inspection.

The QAM had a discussion with the administrator regarding labelling of water bottles. The QAM suggested a label maker to make individual labels for each child.

The QAM observed the children playing in the indoor play area and reading a book with the operator. The children were also observed transitioning to the outdoor play area, the children were observed playing to pretend cooking and pretend fire making with branches and leaves. The QAM also observed the children transitioning for lunch time and then nap time.
