Comments: Attendance records were incomplete. Some departure and arrival times were missing within one of the school age rooms. Ensure these are documented as children arrive and leave facility.

Comments: Slide is cracked. Administrator stated that this has been brought to the school's attention to be fixed. Children are not permitted to use the slide until this has been completed. Another piece of equipment has been partially removed from the playground, awaiting replacement. This has been sectioned off in the mean time. Please provide an approximate date for repair for both pieces of equipment (or proof of work order from the district).

Comments: Afterschool Classrooms 114 & 116 - some books, board game boxes, and puzzles are in poor shape. To be repaired / replaced. Afterschool Classroom 116 - Table and chairs in dramatic play area showing wear. These will soon need to be replaced. Afterschool Classroom 116 - Chair in quiet corner is in poor repair - add a cover that can be laundered or replace. Preschool Classroom - Area rug in reading area is fraying. To be replaced. Some toy storage containers are accumulating dust and debris and require cleaning. Some books are also in poor repair-replace. Bean bag chairs to be cleaned. Recommended purchasing a cover that can be laundered for both bean bag chairs.			

General Comments
<p>Completed renewal inspection today.</p> <p>The preschool children were observed preparing to go outdoors, eating their lunch and freely circulating the indoor play area.</p> <p>Staff members were observed sitting with the children at the table for lunch and engaged in conversation. Shepherd's pie was served for lunch today.</p> <p>Invitations (ex: ice cube trays with colored water and droppers, water play within sensory containers, puzzles etc.) were set up for the children to explore. Some children were also observed building and constructing a "mini world" using loose parts, items from nature and playing cooperatively.</p> <p>The preschool children each have an up to date portfolio containing creative art pieces, learning stories and other forms of documentation that demonstrate interests and learning. Staff indicated that these are still a work in progress but that the portfolios will be soon moved to an accessible shelf for the children to review as they wish.</p> <p>The school age program rooms also displayed recent documentation demonstrating the children's interests and purposeful programming. Art projects (ex: talking sticks, bird feeders), webs, and photos of the children were observed throughout both school age environments.</p> <p>Extreme Allergy Management Plan was completed and on site for a child with an extreme allergy. This plan was reviewed in 2021.</p> <p>Discussed playground equipment. If repair dates are unknown, please submit a work order with the district and submit documentation to inspector to notify of approximate date for repairs to occur.</p>
