General Comments
<p>A Monitoring Inspection was completed this morning. Children were observed during inside and outside play. While inside, children were observed sitting with an educator, creating homemade binoculars. Others were observed playing with Kinetic Sand. A group of children were also observed in the reading area, that has recently been transformed into an airport, with an airplane, check in table, suitcases, passports, etc. Children were very excited to show QAM their airport! Several forms of documentation, relating to airports were observed throughout the classroom. Other forms of documentation were also observed - children's artwork, family picture wall, photos, and learning stories. Educators were engaged with the children. Educators were observed conversing with the children and taking part in play. Positive child guidance techniques were also observed - educators giving gentle reminders, anticipating children's needs, and reflecting with children on incidents by helping them understand the consequences to their actions and words. A conversation was had with Administrator surrounding the idea of "traveling staff files". It was discussed that this would make things easier, for those staff that travel from one center to the next.</p>
