## **General Comments**

The children were cleaning up and getting ready for snack time when I arrived. The morning snack was yogurt and cherrios.

While the children were eating the operator read a story called "Clark the Shark Loves Christmas" by Bruce Hale. While the operator was reading the story she would ask the children questions about the pictures in the book. When the operator finished reading the story, she asked the children if they liked the book and what part of the book they liked the best.

After snack and story time, the operator asked they children what they wanted to do; play, colour, paint or dance. The children decided to have a dance party, musical instruments and scarves were brough out for the party. Once they were finished dancing the children when to the table to work on a snowflake craft. After craft time the children practiced their Christmas song. The sang Santa in the tune of the Bingo song. Following the Christmas song the children prepared for outdoor play time. The operator had purchased new shovels, and they were eager to shovel off the patio and dig in the snow. While outside the children were observed digging in the snow, making snow angels, hanging out in the playhouse and driving the lil' tykes cars. The operator is currently enrolled in the second-year micro-credential program and has implemented a floor sketchbook. She has a large sketchbook on the floor that the children can draw in anytime they want whether in a group activity or individual. As the children draw, she writes down what the pictures are and see how the "story" and/or "pictures" develop as they continue to draw in the book. This allows the children and operator to make their interests and learning visible.

The facility is very clean and pleasantly organized. There are a variety of materials for the children to learn and explore with.

A routine has been established as seen during snack, lunch and preparing for outdoor play time. The operator promotes independence with the children but is always available when they need help.
