Comments: During the renewal inspection, the Quality Assurance Monitor observed several broken toys in the outdoor play area. This was brought to the operator's attention, and the operator promptly removed all broken toys from the area. Deficiency is now compliant.

Comments: During the renewal inspection, the Quality Assurance Monitor observed that two lunch bags were not labeled with the children's names. The Quality Assurance Monitor reminded the administrator that all food brought from home must be clearly labeled with the child's name. The administrator promptly labeled the lunch bags. Deficiency is now compliant			

<p><b>General Comments</b></p> <p>The Quality Assurance Monitor was on site to conduct the renewal inspection. Child-to-staff ratios were maintained throughout the visit.</p> <p>During the inspection, the Quality Assurance Monitor observed children engaged in various indoor activities, including a glow paint activity, painting birdhouses, reading, lunch, and nap time.</p> <p>A discussion took place with the operator regarding hand hygiene practices. The Quality Assurance Monitor noted that none of the children were observed washing their hands before eating lunch. The operator was reminded of the importance of frequent handwashing to prevent the spread of communicable diseases. The operator acknowledged the concern and mentioned that they are working on adjusting the transition routine to ensure handwashing takes place immediately before meals. The Quality Assurance Monitor emphasized that regardless of the routine, children must wash their hands before eating.</p> <p>Another discussion was held concerning hand hygiene during toileting and diapering routines. The Quality Assurance Monitor observed an educator assisting multiple children with toileting and changing pull-ups without washing their hands between each child. The operator was reminded that handwashing must occur between each child during diaper changes and toileting assistance to maintain proper hygiene and reduce the risk of</p>
