Comments: Currently, the operator stores all cleaning supplies in the garage however the garage door is not locked because it is an emergency exit. Please ensure that all cleaning supplies (toxic materials) are secured behind closet or cabinet that is locked with a lock and key to ensure the safety of the children.			

General Comments
<p>Licensing staff arrived at the licensed facility when the children were outside playing. The children were engaging in a variety of activities. The children were observed digging, balancing, climbing and building. The outdoor play environment allowed the children to engage in individual as well as group learning experiences.</p> <p>The outdoor play environment had ample natural shade during my visit.</p> <p>Licensing staff observed the operator engaging positively with the children. The operator was also observed extending the learning experiences with the children by asking many open-ended questions. One example of this was when one of the children were digging in the digging centre and found a little rock but the child relayed to the operator that he found an "egg." The operator asked the child what he thought was growing in the egg and the child responded by saying, "a beaver."</p> <p>The outdoor play environment has play centres that have natural play materials, such as: different sized blocks for building, a climbing wall for gross motor play, a digging centre for exploring and digging for treasures, just to name a few!</p> <p>After playing outside for most of the morning the children went inside to wash up for lunch. After lunch the children participated in a "circle time" which was led by the children. The operator asked each child what song they would like to sing! After singing songs the children did some yoga. Lots of giggles were heard by all.</p> <p>The operator is very playful and encouraging with the children and was seen engaging positively during the inspection visit.</p>

### General Comments

While conducting the license renewal inspection visit, licensing staff noted that the cleaning supplies were being stored in the garage. The door leading to the garage was not locked as it is an emergency exit. Cleaning supplies are required to be secured in a cabinet or closet that is locked by a lock and key. Please ensure the cleaning supplies are secured in a cabinet or closet that is locked by a lock and key so that they are not accessible to the children.
