| Comments:  | Lysol cleaning spray was stored on a shelf out of reach of the children to enable the administrator to quickly sanitize items during the Covid-19 pandemic, as recommended. ## **General Comments**

During the inspection the children engaged in a wide variety of activities. There were inviting, accessible stations with blocks, a play kitchen, and books available. The administrator set up invitations for playdough play, sensory bins, a snowman word game, and a shaving cream puffy paint art activity. The children were also observed engaging in pretend play with costumes, using the small slide in the indoor space, and flipping through the large documentation binder pointing out photos of themselves in learning stories as well as photos of their pets which were brought in from home. The learning space had a terrarium with environment for stick bugs which the children were able to observe.

The administrator prompted children, when needed, to wash their hands, play gently with friends, and toprepare for transitions to the next part of the routine. She actively engaged in conversation and activities with the children throughout the inspection. The administrator was available to help with activities when needed and asked, such as with help with writing activities and with velcroing costumes but encouraged independence where possible, encouraging children to sharpen pencils, use their safety scissors, and apply glue to their own projects.

Documentation of learning was present on the walls throughout the space at an eye-level the children could engage with. It included artwork completed by the children and learning stories with photos and descriptions of the activities of each child at the centre.

Music played throughout the inspection and children sang or danced along. The children had instruments available to them and played with them. Children had the snacks on the menu and had lunch from home. After the afternoon snack they went outside to play. The administrator encouraged as much as independence as the children were capable of with dressing warmly for outdoors.
