Educators have created a very engaging and inviting learning environment for the infants in their care.

Documentation is displayed taped to the floor for the children to revisit their experiences as they wish. This is a great addition to the room. Documentation is also displayed low on the walls as well. Room is very bright and inviting. The children's dress-up clothes are beautifully displayed on new, low hooks easy accessible for them.

Educators have been participating in Professional Development opportunities: Pedagogical Documentation, Risky Play and Webinars and evidence of their continued learning is displayed in their interactions and ideas they have incorporated into the children's learning environment.

Discussed with the educators supervision of children under 15 months of age: Operator's Manual

* "To ensure that children are appropriately supervised at all times, the child-to-staff ratio must be maintained.

General Comments

* at all times (even nap time) for children younger than 15 months of age."
Discussed that during nap time the reduced ratio cannot happen as there are children under 15 months of age in the infant room. There must be two (2) educators at all times in the "Treasured Beginnings" licensed space. "Play area, Sleep area". If during nap time two children are sleep and four children are awake then one educators must be in the sleep room of the children are on nap mats and two educators must be in infant play space supervising and maintaining ratio.
