General Comments

Preschool children were just about ready to head outside to play when I arrived for today's visit. One educator was reading books with the children while the other was cleaning up from snack. Preschoolers went to go play in the wooded area to explore nature this morning, they were observed playing with sticks, searching for bugs (some were successful), digging, and just simply exploring the nature that was around them.

While outside, educators were observed interacting with the children while they were exploring. Educators also ensured they positioned themselves around the wooded area so that they could see the children at all times. They also ensured they set clear and visible boundaries for where the children could and couldn't go.

Educators created a relaxing and enjoyable environment for lunch time by playing quiet/calming music. Educators were observed sitting at the lunch table engaging in conversation with the children, creating a natural home-like environment.

Children are provided with a quiet time, children who attend this program do not normally nap, but those who do with to nap/rest are provided with a cot. During quiet time, educators set up play invitations at tables, and children were also able to play quietly around the room. Observed children participating in the play invitations (two tables of playdough -rolling pins, different sized containers, nature material, another table with a beading activity), playing Lego, drawing/coloring, and reading books.

When the school aged children arrived from school, they immediately went to wash their hands and had lunch. Once lunch was finished, they were observed free playing around the room (drawing, Lego, board games, reading, hanging out). Educator informed me that they will be going outside shortly. This facility uses the school's outside play space, and the wooded, both are right next door to the facility.

After school educators were observed being attentive to the children and encouraging them too work out any problems they might run into amongst themselves, and stepping in if need be. Observed an abundance of positive child guidance in both preschool and after school rooms.
