General Comments
Upon arriving at the facility, the children were finishing their morning snack and starting to engage in free play activities. The children were observed playing with toy cars and dolls. Later, an educator was heard using an active listening technique to get the children's attention. A verbal prompt was given to the children to use the washroom before getting ready to go play outside. The educators were observed properly changing some of the children's diapers before helping the rest of the children get dressed.
Once dressed, an educator took a first group outside to play. A headcount was done while entering the playground. The first aid bags, water bottles and daily attendance records were brought outside with the children. While outside, the children played on the climbing structures and in the snow with multiple accessories such as spoons, shovels and bowls. The educators were observed engaging in the children's activities while supervising. A group of children engaged in imaginary play with one educator while another was observed playing on the climbing structure and the slides. Later, a verbal prompt was given to return inside.
Once inside, the children stored their personal belongings in the labelled cubbies with the help of the educators. Hand washing occurred before the children had lunch. During lunch, the educators helped the children open their containers and encouraged them to eat their meals. After lunch, the children engaged in free play activities such as playing with toy trucks, dolls and dolls houses and large Legos blocks. The educators were observed preparing the beds for the children's nap. Lunch tables were sanitized, and floors were swept before transitioning to quiet time. A meditation was put on to help the children settle into quiet time or nap time. The educators set up invitations to play for the children that did not take a nap.
The children's personal belongings were properly stored and labelled. Pictures of the children's families and recent winter artifacts were observed. Daily attendance, cleaning records and playground safety checks were verified and found to be complete. Proper diaper changing procedures were followed and the washrooms were clean. Toxic products were locked by key. The indoor environment was clean, well-organized and had a sufficient and various play materials. No outdoor safety hazards were observed. The educators were observed kneeling to speak to the children and were actively engaged in play with the children. The educators were also patient and calm with the children.
