Comments: Painting has been completed throughout rooms as per renewal inspection. This was completed on Oct.4, 2021. The division within the infant room is not working as noted on renewal inspection. The baby gate that had been used to divide the room was being shaken by the children and had become wobbly and insecure as a result. This was removed and has been replaced with low level shelving, however, now the children are using the shelving to climb over to the opposite side. Discussed with administrator. Requested that the facility devise a plan to rectify this safety issue and that the plan is submitted to licensing staff no later than October 15, 2021.

The way the environment is set up within the infant room, is permitting infants to climb over low level shelving to access the other side of the room. This has become a safety concern and the facility is also at risk of exceeding maximum group size.
