Positive interactions between the operator and children were noted, such as the operator getting down to the children's level when communicating. The children are engaged in their play.</p> <p>Although the operator's certificate for the Introduction to Early Childhood Education is posted on the wall, the Quality Assurance Monitor recommends that a copy also be placed in the staff file for documentation purposes.</p> <p>The Quality Assurance Monitor recommends that the license be renewed.</p> |
