General Comments					

There were invitations for play set up at the tables upon arrival however the 5 children that were in attendance were engaged in lego at a table for a period of time and then moved into an art activity. The children were

making rainbows with pre-cut clouds, google eyes and popsicle sticks.

All meals and snacks are provided by the parent(s) or guardian(s). Water is accessible to the children at all times; they are stored in their labeled water bottles.

Please continue to develop a program that is based on the interests of the children. The educators are webbing and licensing staff advised the administrator that a picture could be taken of this type of planning and kept in a binder for verification. A pre-planned program should be kept on file so that licensing staff can see the development of the children's learning for the year. Licensing staff is going to refer facility to curriculum team for support but also recommends that the curriculum framework is used for reference.

The materials in the outdoor play space cannot carry stagnant water. Please drill holes in the tires so that they drain properly. There is also a board in the playhouse that needs to be repaired.

Educators are engaged with the children at their level. They do activities, speak to them and ask questions about their play. They respond to the children's emotions and were observed sitting with the children and giving hugs when the children were upset or crying. As this small group of children's busy behaviours escalate fast, more defined learning centres with more materials is recommended.
