Comments: 5 out of 15 audited files are missing the medical practitioner information. Operator must ensure that information is provided at time of registration. All files must be completed at registration.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (b) child records that include: (iv) the name, address and telephone number of at least two individuals authorized by the child's parent or guardian to pick up the child and to be contacted in case of an emergency if the parent or guardian cannot be reached,	24(1)(b)(iv)	Oct 26, 2022	
Comments: 6 out of 15 audited files are missing the 2 emergency contacts. All child files must have at least 2 emergency contacts that can be reached in case of emergency. All files must be completed at registration.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Oct 26, 2022	
Comments: Toxic items were found in a cabinet in the bathroom and in a cabinet in a classroom with no lock and unlocked. Toxic products must be locked at all times.

Comments: During renewal inspection, medications were found in a cabinet with no lock and unlocked. Medications must be locked and inaccessible to children.
