Comments: Numerous children's file was missing the signed statement from the parents confirming they have read and understood the parent handbook. Administrator will have the parents sign a statement and put a copy if the children's file.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Sep 22, 2023	
Comments: The closet where some toxic product is stored is not locked and secured by a key. Operator will replace the door knob with one that can be locked by key.
