Comments: The inspector observed that 1 staff member is missing the proof of registration to the Introduction of Early Childhood Education course in her staff file. The administrator must ensure that the proof is inserted into the staff file.			
11.1(3) A staff member who works directly with infants or preschool children shall complete in each year 10 hours of training approved by the Minister related to the curriculum used at the designated facility.	11.1(3)	Nov 29, 2024	
Comments: The inspector observed that the eligible educators have not completed their professional learning hours in the last year. The operator must ensure that all eligible educators are continuing their education and completes the professional learning hours.			
12(2) An operator of a licensed facility shall ensure that a criminal record check or a vulnerable sector check, as the case may be, and a check with the Department of Social Development is conducted on each individual before he or she becomes a staff member.	12(2)	Nov 12, 2024	Nov 08, 2024
Comments: The inspector observed that a Social Development check is missing in one of the educators' files. The inspector asked the administrator if a copy is available. If not, the staff member cannot stay inside the facility. While on site, the administrator printed a copy. Deficiency is now compliant			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (c) staff member records that include (iii) a description of the staff member's duties and responsibilities.	24(1)(c)(iii)	Nov 20, 2024	
Comments: The inspector observed in 1 staff file that her job description is missing. The administrator must ensure that all staff files are fully completed.

Comments: The inspector observed that a Social Development check is missing in one of the educators' files. The inspector asked the administrator if a copy is available if not, the staff member cannot stay inside the facility. While on site, the administrator printed a copy and inserted into the staff file. Deficiency is now compliant

Comments: 1 staff member is missing a copy of a valid first aid certificate in her staff file. The administrator told the inspector that the staff member is currently registered for the course.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (g) attendance records of staff members.	24(1)(g)	Nov 20, 2024	
Comments: The inspector observes that the staff member attendance is conducted on an application on their personal phone. The staff member record must be accessible to the inspector.			
28(2) An operator of a licensed facility shall carry out emergency evacuation and fire drills monthly.	28(2)	Nov 22, 2024	
Comments: The inspector observed that the fire drill was not conducted for the month of October. The administrator must ensure to conduct the fire drills with the children and staff member once a month.			
36(4) The rest area of a full-time early learning and childcare centre and an early learning and childcare home shall allow for a space of at least 46 cm between each crib, portable playpen, cot or nap mat.	36(4)	Nov 08, 2024	
Comments: The inspector observed that the crib inside the sleep area is not separated with a space of 46 cm. The inspector discussed with the educators, and none moved the cribs. The administrator must ensure that the space between each crib is respected.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Nov 08, 2024	Nov 08, 2024
Comments: The inspector observed a Febreze Air Freshener spray bottle under the sink in the infant room. The administrator must ensure that all Toxic Products are all locked. While on site, the administrator immediately locked the spray bottle inside the locked cabinet. Deficiency is now compliant			
45(3) If a child has or may be affected by a disease that is required to be reported under the Public Health Act and the regulations under that Act by the operator of a licensed facility, the operator shall (a) complete the forms provided by the Minister.	45(3)(a)	Nov 21, 2024	
Comments: The inspector told the administrator that in the last year, they had to send children home from different health reasons. However, no management of potential illness forms were completed. The administrator must ensure that the forms are always completed when a child is at the facility and leaves for medical			
48(4) If an infant is receiving services at a licensed facility, the operator shall (b) ensure that an infant who is bottle-fed is not fed in a crib.	48(4)(b)	Nov 11, 2024	Nov 08, 2024
Comments: The inspector observed an infant lying down and drinking a bottle. The inspector told the administrator, and the educator immediately sat down the child with the bottle.			
9(1) The child-to-staff ratio is one educator for each of the following groups of children of the same age receiving services at a full-time or part-time early learning and childcare centre: (a) three infants or fewer; (b) five children or fewer who are two years of age; (c) eight children or fewer who are three years of age; (d) ten children or fewer who are four years of age or older, but who are not yet attending school; and (e) 15 school-age children or fewer.	9(1)	Nov 08, 2024	Nov 08, 2024

The administrator asked the inspector if she can stay in this group because of the shelf's separation in both classroom, inspector said no. Immediately, a staff member came and replace the 18-year-old. Deficiency is now compliant
