Comments: Surfacing depleted under swing set. Protective surfacing is required for any stationary swing set. ### General Comments

A Monitoring Inspection was conducted on October 21, 2024.

Children were observed during rest time, indoor free play, and snack time. Proper handwashing was observed during the transition to snack time. Educators mentioned that the children are currently very engaged with sensory experiences, including open-ended art materials and making music with instruments. They are also noticing and exploring the changing seasons. Educators were seen using positive language and providing gentle reminders to guide the children.

Parents of children attending the center are allowed entry at any time. Outdoor play is scheduled for at least one hour within each four-hour block of time, weather permitting, when most children are present. The center maintains clear visibility for posting the license, current inspection report, monitoring reports, and any orders for compliance. Rest periods meet individual needs and do not exceed two consecutive hours, with all nap equipment being at least 5 cm thick. Snacks are provided every three hours, and meals are offered at recognized meal times. The daily routine is posted in each room.

## General Comments

Evacuation procedures are prominently displayed, and life-threatening allergies are clearly posted. The facility has a varied supply of appropriate equipment, materials, books, and toys, with several well-defined learning centers such as building, reading, dramatic play, and science. Traffic areas are kept clean, and outdoor walkways are clutter-free. Toxic products, such as chemicals and cleaners, are locked away and inaccessible to children. The diaper changing area is located within a meter of a sink, with diaper-changing procedures posted and visible. Infant bottles are labeled and used only for the intended child. The infant outdoor play area is either separate from or used at different times than the play area for older children.

Daily activities are purposefully planned and documented in the program, offering opportunities for both individual and group experiences. Various forms of literacy are incorporated into the indoor environment. Portfolios are being completed with the children, and multiple forms of documentation were observed throughout the facility. Educators provide opportunities for the curriculum to be extended outdoors, and efforts are made to bring elements of the natural world into the classroom. Curriculum webs have been completed with the children and expanded upon by the educators to further enhance learning experiences.
