10(6) The number of children grouped at a full-time or part-time early learning and child- care centre shall not be more than the number that requires two educators.		10(6)	Oct 1	2, 2022		
Comments: A group cannot exceed the requirement of two educators which is equivalent to 2.000. Today there was 22 children = 6-3 year old's, 7-4 year old's and 9 school age children. This is equivalent to 2.053 which is over the maximum group allowed. If all children would be present at 26, the ratio would be equivalent to 2.478 which again is above maximum group size allowed. Therefore, the children cannot amalgamate in one room and will need to be divided in two groups and both rooms will need to be utilized at all times.
