**General Comments**

A Monitoring Inspection took place today, June 4, 2024.

Children were observed during indoor free play and nap time. Educators reported that the children are currently very interested in building, with those in the preschool room seen constructing a school bus using large blocks. Recent activities in both the two/threes and preschool rooms were purposefully planned to reflect the children's interests. The floors in both classrooms were clean. In the two/threes room, a diverse and ample supply of art materials were provided. The room has been reorganized into new learning centers, with materials neatly organized and clean on the shelves. The washroom floors were clean, all toxic products had been removed, and personal items were stored in separate bags. The outdoor sandbox in the infant area was covered, containing sufficient sand, and the preschool outdoor sandbox also had new sand and coverings.
