<p>School aged children were not present during today's inspection as they were still in school. Preschool program was inspected during today's monitoring inspection.</p> <p>When I arrived for today's monitoring inspection, there was one group of children outside and one was inside. The group that was inside was observed partaking in many different activities around the room, some were observed doing a rainbow craft, a flower craft, playing with cars and boats, and some children were just hanging out on the couch playing with quiet tabletop toys. The children who were outside were observed playing on the play structure, climbing dome; they were also observed planting flowers! The educator who was helping the children plant the flowers was observed ensuring she explained what was required to help the flower grow, the children were very excited to get into the soil and plant their seeds!</p> <p>Educators were observed documenting the children's process of planting their flowers by taking pictures. All children were outside playing shortly after my arrival. They were observed playing on the play structure, dome, digging in the pea gravel, with balls, and running around. Children approached one of the educator's and asked to color, the educator wasted no time in going inside and bringing out markers, paper, a box of connecting toys and some chalk.</p> <p>Educators were observed ensuring they were always moving around the outside play space and interacting with different groups of children to ensure they were able to properly supervise.</p> <p>A reminder, please ensure that once staff who are working with preschool aged children complete either their</p>
