Educators were engaged and very attentive to the children at time of visit. Redirection and distraction were used with more challenging behaviours.

The Operator is adding another outdoor play space which currently does not meet regulations under the Act. This space is currently not licensed by the Department. Please submit a change a service application in order to have this space licensed. It is not recommended that the children continue to use the space until licensing requirements are met. Please ensure that all CSA regulations, manufacturers instructions and the early childhood education regulations and Act are adhered to.
